Bibliographic information of all doctoral dissertations published in Finland are stored in the Finnish National Bibliography and the collection databases of libraries permanently. Aalto University collects information on the date and place of birth of its doctoral candidates for the use of the Finnish National Bibliography and the collection databases of libraries. With this information, persons with identical names in the database can be distinguished from each other, and publications are connected to their proper author.*
